

Information on Protection Against Product Piracy

Information concerning measures in cases of infringement of intellectual property rights including counterfeiting and piracy

This information sheet is intended to give exhibitors and providers of goods and services some initial information concerning procedures when intellectual property rights have been infringed.

PROCEDURES

1. Border seizure

In the run-up to a trade fair, seizure at the border is an effective legal remedy when goods are imported into the single European market.

An application for border seizure may be made online via ZGR-online, the German Customs Administration's centralized online accessible database for the protection of intellectual property rights.

2. Trade fair seizures / criminal proceedings

Where intellectual property rights have been infringed by offenders registered in an EU Member State, a criminal (public prosecution) proceeding may be initiated. The customs service and the police take an active part in such proceedings as auxiliary officers of the public prosecutor's office. In this capacity, the customs service and the police may remove from the exhibition booth infringing products that come from third countries in the EU, and seize such products for use as evidence in criminal proceedings that follow.

3. (Fast track) court proceeding before the Regional Court (Landgericht) of Brunswick

The patent litigation chamber (Patentstreitkammer) at the Regional Court of Brunswick is competent in the state of Lower Saxony for disputes arising from infringements of patents, utility models, designs and trade marks. If such disputes arise from exhibitions on the Hannover trade fair grounds, in urgent and appropriate cases the patent litigation chamber is prepared to conduct court proceedings at short notice during the trade fair on the Hannover trade fair grounds.

Due to the announcement of exhibition protection for the IAA TRANSPORTATION, the so-called trademark priority for trademark or utility model applications applies to exhibitors in accordance with § 35 MarkenG, § 6a GebrMG and § 15 De-signG. This means that the date of application for the respective trademark, utility model or design is not determined by the date of the respective application, but by the earlier date of the exhibition, if applicable.
